EVENT CATEGORIES:

The tournament will be open to seniors (50 or over by December 31, 2018). Players can compete in one single age category in Men's Doubles, Women's Doubles, and Mixed Doubles. Age groups will be categorized by ages 50-59, 60-69, 70-79 and 80+. Age groups will be determined by the age of the younger player. Must have four teams for a bracket to go.

TOURNAMENT FORMAT:

The format will be double elimination. A match will consist of one game to 15 points and must win by two. In finals match, if it is a team's first loss, then there will be a tie breaker match. The match will consist of one game to 11 and win by two. All local rules will be used first, then it will be governed by the Official United States American Pickleball Association (USAPA) Rules and Regulations.

EQUIPMENT USED:

Green Jugs Indoor Balls (USAPA Approved)
The tournament will be played indoors on rubberized gym flooring.

POLICIES:

The registration form **must include partner's names** at the time of registration. **Incomplete forms will not be processed.** Players may not enter two age groups in the same event. Events may be cancelled, combined and restricted at the discretion of the tournament director. Cancellations will be accepted only from the cancelling player. No refunds will be given for cancellations. It is the player's responsibility to find a replacement partner. All decisions of the tournament Director are final.

Tournament Overview

The tournament will be open to seniors (50 or over by December 31, 2018). Players can compete in one single age category in Men's Doubles, Women's Doubles, and Mixed Doubles Tournament. Age groups will be categorized by ages 50-59, 60-69, 70-79 and 80+.

The format is double elimination. A match will consist of one game to 15 points and must win by two. In finals match, if it is a team's first loss, then there will be a tie breaker match. Tie breaker match will consist of one game to 11 and win by two.

Sunday will be Open Play for all registered players.

Event fees are \$25 for first event and \$5 for each additional event if registered by January 26. Registrations after January 26 will be \$30 for first event and \$5 for each additional event. **Registration forms must be postmarked by Friday February 9, 2018.**
